एजबस्टन में शतक लगाकर कोहली आईसीसी टेस्ट रैंकिंग के शीर्ष पर पहुंचे

### जीत में तकनीक का हाथ



पाकिस्तान में पिछले महीने समाप्त हुए आम चुनावों में एक ऐप्लिकेशन और 5 करोड़ वोटरों से जुड़ी जानकारी क्रिकेटर इमरान खान की जीत के पीछे एक अहम कारण रही। हालांकि विपक्षियों का आरोप है कि खान को पाकिस्तानी सेना से गोपनीय सहायता भी मिली थी। खान की पाकिस्तान तहरीक-ए-इंसाफ

(पीटीआई) पार्टी ने ऐप और डेटा का उपयोग

किया, जिससे चुनाव से पहले वोटरों को लाक्षित करने और चुनाव वाले दिन समर्थकों को तैयार करने में सहायता मिली। हालांकि 25 जुलाई के आम चुनाव में तकनीक के प्रयोग को लेकर पार्टी में संकोच

था और उन्हें संशय था कि विरोधी पार्टियां भी इसका उपयोग कर सकती हैं लेकिन पार्टी के कई कार्यकर्ताओं ने बताया कि ऐप ने उनके चुनावी अभियान को पूरी तरह से बदल दिया और उन्हें बढ़त दिलाई।

जिस समय चुनाव केंद्र की सही जानकारी देने के लिए सरकारी टेलीफोन सेवा जवाब दे रही थी, ऐसे में चुनाव के दौरान समर्थकों को जुटाने में ऐप काफी उपयोगी रहा। इस्लामाबाद सीट से विजयी असद उमर के निजी सचिव और एक छोटी सीएमएस टीम के प्रमुख आमिर मुगल को शुरू में संशय था कि सभी विधानसभाओं के डेटा का संग्रह. वोटरों को चिह्नित करना, उनको ऐप से जोड़ना और चुनाव वाले दिन उनकी उपस्थिति सुनिश्चित करने का काम कैसे होगा। चुनाव के बाद मुगल ने रॉयटर्स को बताया, 'जिस काम में कई दिन लग जाते थे वह 1-2 घंटे में पुरा हो गया।' खान की पार्टी ने 272 सीटों में से 115 पर जीत दर्ज की, जबिक नवाज शरीफ की पार्टी 64 सीटों के साथ दूसरे स्थान पर रही। इसलिए, एक छोटी सी टीम द्वारा बनाए गए सीएमएस सॉफ्टवेयर ने इस चुनाव में बड़ी भूमिका निभाई।
