PUBLIC ANNOUNCEMENT FOR THE ATTENTION OF EQUITY SHAREHOLDERS/BENEFICIAL OWNERS OF FULLY PAID UP EQUITY SHARES OF INDIABULLS VENTURES LIMITED FOR THE BUY-BACK OF FULLY PAID UP EQUITY SHARES THROUGH TENDER OFFER UNDER THE SECURITIES AND EXCHANGE BOARD OF INDIA (BUY-BACK OF SECURITIES) REGULATIONS, 2018, AS AMENDED.

This Public Announcement (the "Public Announcement") is being made pursuant to the provisions of Regulation 7(i) of the Securities and Exchange Board of India (Buy-back of Securities) Regulations, 2018, as amended (the "Buy-back Regulations") for the time being in force including any statutory modifications and amendments from time to time and contains the disclosures as specified in Schedule II of the said Regulations.

OFFER FOR BUY-BACK OF UP TO 6,66,666,666 (SIX CRORES SIXTY SIX LACS SIXTY SIX THOUSAND SIX HUNDRED SIXTY SIX) FULLY PAID UP EQUITY SHARES OF THE FACE VALUE OF RS. 2/- (RUPEES TWO ONLY) EACH AT A PRICE OF RS. 150/- (RUPEES ONE HUNDRED FIFTY ONLY) PER FULLY PAID UP EQUITY SHARE, PAYABLE IN CASH, ON A PROPORTIONATE BASIS THROUGH THE "TENDER OFFER" ROUTE AS PRESCRIBED UNDER THE BUY-BACK REGULATIONS USING STOCK EXCHANGE MECHANISM.

1. DETAILS OF BUY-BACK OFFER AND OFFER PRICE

FINANCIAL EXPRESS

- 1.1 The Board of Directors (the "Board" which shall be deemed to include Buy-back Committee, constituted by Board and authorized to exercise its powers) of Indiabulls Ventures Limited (the "Company"), at its meeting held on October 11, 2019 (the "Board Meeting") has, subject to the approval of the shareholders of the Company by way of a special resolution through a postal ballot/ e-voting, pursuant to the provisions of Article 12 of the Articles of Association of the Company, Sections 68, 69 and 70 and all other applicable provisions, if any, of the Companies Act, 2013, as amended (the "Companies Act"), the Companies (Share Capital and Debentures) Rules, 2014, to the extent applicable, and in compliance with the Buy-back Regulations and subject to such approvals of statutory, regulatory or governmental authorities as may be required under applicable laws including the requirements pursuant to and in terms of Section 68(2)(c) of the Companies Act, approved the Buy-back of up to 6,66,666 (Six Crores Sixty Six Lacs Sixty Six Thousand Six Hundred Sixty Six) fully paid up Equity Shares of the Company having face value of Rs. 2/- each ("Equity Shares") (representing 12.61% of the total number of fully paid up Equity Shares, as on September 30, 2019) at a price of Rs. 150/- (Rupees One Hundred and Fifty only) per Equity Share ("Maximum Buy-back Price") payable in cash for a total consideration not exceeding Rs. 1,000 Crores (Rupees One Thousand Crores only) excluding transaction costs viz. applicable taxes/duties and other incidental and related expenses ("Transaction Costs") (hereinafter referred to as Maximum Buy-back Size), being 22.96% and 20.78% of the total paid-up equity share capital and free reserves (including securities premium account) as per the latest available audited financial statements of the Company for the financial year ended March 31, 2019, on standalone and consolidated basis, respectively, which is within the statutory limit of 25% of the total paid up equity share capital and free reserves as per standalone and consolidated audited accounts of the Company, through the Tender Offer route as prescribed under the Buy-back Regulations (the process being referred hereinafter as Buy-back), on a proportionate basis, from the equity shareholders / beneficial owners of the Equity Shares of the Company who hold Equity Shares as on December 19, 2019 (the "Record Date").
- 1.2 The shareholders of the Company approved the Buy-back, by way of a special resolution, through postal ballot (including e-voting) pursuant to the postal ballot notice dated October 22, 2019 (the "Postal Ballot Notice") on December 4, 2019 and the results of which were announced on December 5, 2019.
- 1.3 The Maximum Buy-back Size does not include any transaction costs viz. applicable taxes/duties and other incidental and related expenses incurred or to be incurred for the Buy-back like filing fees payable to Securities and Exchange Board of India ("SEBI"), advisors/legal fees, public announcement publication expenses, printing and dispatch expenses and other incidental and related expenses, etc.
- 1.4 The Equity Shares are listed on the BSE Limited (the "BSE") and the National Stock Exchange of India Limited (the "NSE") (hereinafter together referred to as the "Stock Exchanges"). The Global Depository Receipts ("GDRs") of the Company are listed on the Luxembourg Stock Exchange.
- 1.5 In addition to the regulations/statutes referred to in paragraph 1.1 above, the Buy-back is also in accordance with the Companies (Management and Administration) Rules, 2014, to the extent applicable and the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended. The Buy-back shall be undertaken on a proportionate basis from the equity shareholders holding fully paid up equity shares of the Company as on the Record Date ("Eligible Shareholders") through the tender offer process prescribed under Regulation 4(iv)(a) read with Chapter III of the Buy-back Regulations. Additionally, the Buy-back shall be subject to applicable laws, implemented by tendering of Equity Shares by Eligible Shareholders and settlement of the same through the stock exchange mechanism as specified by SEBI in its circular bearing reference number CIR/CFD/POLICY CELL/1/2015 dated April 13, 2015 read with the circular bearing reference number CFD/DCR2/CIR/P/2016/131 dated December 9, 2016, as amended from time to time ("SEBI Circulars"). In this regard, the Company will request BSE and NSE to provide the acquisition window for facilitating tendering of Equity Shares under the Buy-back. For the purposes of this Buy-back, BSE will be the designated stock exchange.
- 1.6 Participation in the Buy-back by Eligible Shareholders may trigger capital gains taxation in India and in their country of residence. The transaction of Buy-back would also be chargeable to securities transaction tax in India. In due course, Eligible Shareholders will receive a letter of offer, which will contain detailed note on taxation. However, in view of the particularized nature of tax consequences, the Eligible Shareholders are advised to consult their own legal, financial and tax advisors prior to participating in the Buy-back.
- 1.7 A copy of this Public Announcement is available on the website of the Company at www.indiabullsventures.com and is expected to be available on the website of the SEBI at www.sebi.gov.in during the period of Buy-back and on the website of the Stock Exchanges at www.bseindia.com and www.nseindia.com, respectively.

2. NECESSITY FOR BUY-BACK

The Buy-back of Equity Shares, through Tender Offer route is being implemented in keeping with the Company's desire to enhance overall shareholders' value. The Buy-back would lead to reduction in outstanding number of Equity Shares and may consequently increase earnings per Equity Share over a period of time. This would in turn lead to improvement in return on net worth and other financial ratios and contribute to maximization of overall shareholders' value. With the above objective in mind, the Board of the Company at its meeting held on October 11, 2019, subject to consent of shareholders, has approved Buy-back of up to 6,66,66,666 Equity shares of face value of Rs. 2/- each (representing 12.61% of the total number of fully paid-up equity shares of the Company, as on September 30, 2019) at a price of Rs. 150/- per Equity Share payable in cash for a total consideration not exceeding Rs. 1,000 Crores, excluding Transaction Costs.

The Buy-back is a more efficient form of distributing surplus cash to the equity shareholders compared to other alternatives including interim dividend, inter-alia, for the following reasons:

- The Buy-back gives an option to the equity shareholders to either participate
 in the Buy-back and receive cash in lieu of Equity Shares accepted under the
 Buy-back or not participate in the Buy-back and enjoy a resultant increase in
 their percentage of shareholding in the Company post the Buy-back;
- The Buy-back would help in improving certain key financial ratios of the Company;
- The Buy-back which is being implemented through the Tender Offer route as prescribed under the Buy-back Regulations, would involve a reservation for small shareholders as defined in this Regulations.
- iv. As defined in the Buy-back Regulations, a small shareholder is a shareholder who holds Equity Shares having market value, on the basis of closing price on the recognized stock exchange in which highest trading volume in respect of such Equity Shares, as on the Record Date, of not more than Rs. 2,00,000/-(Rupees Two Lakhs only).
- 3. MAXIMUM NUMBER OF SECURITIES THAT THE COMPANY PROPOSES TO BUY-BACK

The Company proposes to Buy-back up to 6,66,66,666 (Six Crores Sixty Six Lacs Sixty Six Thousand Six Hundred and Sixty Six) fully paid up Equity Shares of the Company having face value of Rs. 2/- (Rupees Two only) each.

4. BUY-BACK PRICE AND BASIS OF DETERMINING THE BUY-BACK PRICE

The Equity Shares are proposed to be bought back at a price of Rs. 150/- per Equity Share. The Maximum Buy-back Price of Rs. 150/- per Equity Share represents (i) premium of around 22% on BSE and around 20% on NSE over the volume weighted average price of the equity shares on BSE and NSE respectively for 2 weeks preceding the date of the Board Meeting, in which the proposal of the Buy-back was considered and (ii) premium of around 51% over closing market price of equity shares of the company at NSE and BSE respectively preceding the date of Board Meeting in which the proposal of buy back was considered.

5. MAXIMUM AMOUNT REQUIRED UNDER THE BUY-BACK AND ITS PERCENTAGE OF THE TOTAL PAID UP CAPITAL AND FREE RESERVES

The maximum amount required under the Buy-back will not exceed Rs. 1,000 Crores (Rupees One Thousand Crores Only), excluding Transaction Costs, representing 22.96% and 20.78% of the total paid-up equity capital and free reserves (including securities premium account) as per the latest available audited financial statements of the Company for the financial year ended March 31, 2019, on standalone and consolidated basis, respectively.

The Buy-back will not result in any benefit to the Promoter and Promoter Group or any Directors of the Company except to the extent of cash consideration received by them from the Company pursuant to their respective participation in the Buy-back in their capacity of Equity Shareholders of the Company and the change in their shareholding as per the response received in the Buy-back, as a result of the extinguishment of Equity Shares which will lead to reduction in the Equity Share Capital of the Company post Buy-back.

CONFIRMATIONS FROM THE COMPANY AS PER THE PROVISIONS OF THE BUY-BACK REGULATIONS AND THE COMPANIES ACT:

10. RECORD DATE AND SHAREHOLDERS ENTITLEMENT 10.1. As required under the Buy-back Regulations, the Company has fixed

Social media firms may be forced to verify users

INDIA'S PROPOSED NEW privacy bill may require large social media platforms to offer an identity-verification option, a potentially precedent-setting effort to rein in the spread of 'fake news', two government sources told *Reuters* on Thursday.

The requirement would likely raise a host of technical and policy issues for companies including Facebook and its WhatsApp and Instagram units, Twitter and Chinese app TikTok, all of which have millions of users in India.

Companies would have to offer a mechanism for users to prove their identities and display that verification publicly, akin to the blue checkmark that Twitter has used to confirm the authenticity of some high-profile accounts, including those belonging to celebrities and politicians.

Verification would be optional for users, the sources said.



The Personal Data Protection Bill, whose first draft was made public last year, is keenly awaited by top technology companies and industry stakeholders as it could alter the way all major internet companies process, store and transfer Indian consumers' data.

The identity verification requirement, introduced in the latest draft of the bill, would be one of the most ambitious efforts globally to battle disinformation and fake news, which is often spread by pseudonymous or fake accounts.

"The idea was to reduce the spread of fake news and online trolling," said one of the sources, a federal IT ministry official.

Saab wants control if it wins \$15-billion India fighter deal

SAAB WANTS CONTROL of local manufacturing in India if it beats the likes of Boeing and Lockheed Martin in the race for the world's biggest warplane contract.

The Swedish manufacturer is in the running to supply 114 Gripen fighters in a deal valued at more than \$15 billion as Prime Minister Narendra Modi seeks to modernize armed forces reliant on mostly Soviet-era equipment in the face of threats from China and Pakistan. At the same time, Saab faces a requirement that at least 85% of the planes be built locally in partner-

ship with Indian firms. "If a company needs to take responsibility for quality, time, cost and capability that's required by the Indian customer, I want to have some sort of control of that," Saab chief executive officer Micael Johansson said in an interview in New Delhi. It's also important that Saab be able to export India-built Gripens to fulfils

global demand, he said. Saab has teamed up with

Indian billionaire Gautam Adani on its bid, while Boeing has pitched its F/A-18 in partnership with state-run Hindustan Aeronautics and MahindraDefence Systems. Lockheed has offered the F-21, specifically designed for the Indian bid and a close relation of the F-16, with conglomerate Tata Group, while the Eurofighter Typhoon and France's Dassault Aviation Rafale are also in the mix.

"We just need to find a mechanism and the sort of balance between investing and having some sort of control, and not to be liable for things that we cannot control in the Indian market," said Johansson, who was took over as CEO in October and was in India as part of a Swedish royal delegation.

India allows up to 49% of foreign direct investment in defense, though it could be possible to hold more with government approval and if the venture provides 'access to modern technology'.

India wants to know what will food look like in the year 2099

THE CHANGING CLIMATE has made the Central government so anxious about food security that politicians are now trying to predict the country's crop output until as far as 2099.

Global warming is a factor in the nation's increased number of extreme weather events, and simulation studies showed the country's wheat yields may plunge between 6% to 25% toward the end of the century, agriculture minister Narendra Singh Tomar said in a written response to parlia-

Fluctuating weather patterns will also reduce production for most other crops including maize and rice, the minister said. Chickpeas are an outlier, with output likely to rise as much as 54%, he said.

India, the world's second most populous nation, has already been grappling with the impact of climate change. This year's monsoon, which typically waters more than half of the country's total farmland, caused floods and poor rains at the same time. Rain

was more than normal in 12 out of 36 states, while four states received deficient show-

The South Asian country will have about 1.4 billion people to feed by 2100, according to the United Nations. While the production of food grains has jumped five-fold since 1950-51, 14.5% of the population still suffer from undernourishment, with India ranking near the bottom of the Global Hunger Index, according to the UN's Food and Agriculture Organisation.

S Mahendra Dev, director for Indira Gandhi Institute of Development Research remained skeptical over the country's long-term forecast.

"One can predict production for the next 20 to 30 years but beyond that, it is very difficult," said Dev. "With the changing climate, technology is also changing. Like water for irrigation is a problem, but then agriculture is also adapting and solutions are coming for judicious use of water for irrigation."

10. RECORD DATE AND SHAREHOLDERS ENTITLEMENT

- 10.1. As required under the Buy-back Regulations, the Company has fixed December 19, 2019 as the record date for the purpose of determining the entitlement and the names of the equity shareholders who are eligible to participate in the Buy-back.
- 10.2. The Equity Shares to be bought back as part of the Buy-back are divided into two categories: i. Reserved category for small shareholders; and ii. General category for all other shareholders.

On the basis of the shareholding on the Record Date, the Company will determine the entitlement of each Eligible Shareholder, including small shareholders, to tender their Equity Shares in the Buy-back. This entitlement for each Eligible Shareholder will be calculated based on the number of Equity Shares held by the respective shareholder on the Record Date and the ratio of the Buy-back applicable in the category to which such shareholder belongs. The final number of Equity Shares that the Company will purchase from each Eligible Shareholder will be based on the total number of Equity Shares tendered. Accordingly, the Company may not purchase all of the Equity Shares tendered by an Eligible Shareholder.

ताला तोड कर बंगला खाली कराएगी सरकार

जनसत्ता ब्यूरो नई दिल्ली, 5 दिसंबर।

विगत जून में लोकसभा चुनाव के बाद 230 पूर्व सांसदों से लुटियन दिल्ली में आबंटित सरकारी बंगले खाली कराने के लिए सरकार की सख्ती के बावजूद पांच पूर्व सांसदों ने अभी तक बंगला खाली नहीं किया है। इनमें से चार पूर्व सांसद बंगले में ताला लगाकर कई दिनों से नदारद हैं, ऐसे में संपदा निदेशालय ताला तोड़कर ये बंगले खाली कराएगा।

निदेशालय के सूत्रों के अनुसार पूर्व सांसद धनंजय महाडीक (राकांपा), डॉ गोपाल के.(अन्नाद्रमुक), एम मुरली मोहन (तेदेपा) और भाजपा के मनोहर ऊंटवाल के बंगलों पर कुछ समय से ताला लगा है। कांग्रेस की पूर्व सांसद रंजीत रंजन ने भी निदेशालय से कई बार नोटिस दिए जाने के बाद भी आवास खाली नहीं किया है। जानकारी के मुताबिक रंजीत रंजन ने बीआर मेहता लेन पर आबंटित अपना बंगला अगले सप्ताह सोमवार तक खाली करने का निदेशालय को लिखित आश्वासन दिया है।

अधिकारी ने बताया कि लोकसभा चुनाव के छह महीने बीतने के दौरान बरती गई सख्ती के फलस्वरूप 230 पूर्व सांसदों से सरकारी बंगले खाली कराने की अब तक की कार्रवाई सफल रही। सिर्फ पांच पूर्व सांसदों ने आवास खाली नहीं किए हैं इस बीच, 70 नवनिर्वाचित सांसदों को सरकारी आवास नहीं मिल पाने का मुद्दा सोमवार को लोकसभा में उठने के बाद निदेशालय ने खाली नहीं हुए बंगलों को ताले तोड़कर खाली कराने की तैयारी शुरू कर दी है।

उन्होंने बताया कि अगले एक दो दिनों में कब्जाधारी द्वारा बंगला खाली नहीं किये जाने पर निदेशालय के अधिकारियों की टीम दिल्ली पुलिस की मौजूदगी में बंगले के ताले तोड़ कर सामान का पंचनामा कर इसे जब्त कर लेगी, जिसे कब्जाधारक के लौटने पर उसे सुपुर्द कर दिया जायेगा।

कर्नाटक विधानसभा उपचुनाव में 66.49 फीसद मतदान

बंगलुरु, 5 दिसंबर (भाषा)।

कर्नाटक में गुरुवार को 15 विधानसभा सीटों के उपचुनाव में लगभग 66.49 फीसद मतदाताओं ने वोट डाला और मतदान कमोबेश शांतिपूर्ण रहा। इस उपचुनाव को राज्य की बीएस येदियुरप्पा सरकार के स्थायित्व के लिए बेहद अहम माना जा रहा है।

मतदान सुबह सात बजे शुरू हुआ और पहले आधे दिन तक मतदान की गति धीमी रही और डेढ बजे तक सिर्फ 33 फीसद मतदाताओं ने मतदान किया। उसके बाद मतदान ने रफ्तार पकड़ी। हालांकि उपचुनाव का मतदान फीसद 2018 के विधानसभा चुनाव के मतदान फीसद से कम रहा। अधिकारियों ने बताया कि 15 निर्वाचन क्षेत्रों में शाम छह बजे तक 37.78 लाख पात्र मतदाताओं में से 66.49 फीसद मतदाताओं ने वोट डाला। मतदान का फीसद बढ़ने की संभावना है क्योंकि कुछ स्थानों पर लाइन में खड़े मतदाताओं को मतदान की इजाजत दी गई। मतदान के आंकड़ों के अनुसार होसकोट में सबसे अधिक 90.44 फीसद जबकि केआर पुरा में सबसे कम 43.25 फीसद मतदान दर्ज किया गया।

इसके अलावा महालक्ष्मी लेआउट में 50.92 फीसद, शिवाजीनगर में 44.60, यशवंतपुरा में 54.13, अथानी में 74.23, कागवाड में 76.27, गोकक में 73.08, येल्लापुर में 77.52, हिरेकरू में 78.63, रानीबेन्नूर में 73.53, विजयनगर में 64.95, चिक्कबल्लापुर में 86.40, के आर पेटे में 80 और हुनसुर में 80.71 फीसद मतदान हो चुका है। ये उपचुनाव 17 विधायकों को अयोग्य करार देने से रिक्त सीटों को भरने के लिये हो रहे हैं। इन विधायकों में कांग्रेस और जद(एस) के बागी नेता शामिल थे।
