भारतीय जनता पार्टी (भाजपा) के एक वरिष्ठ कार्यकर्ता ऋषि त्रिपाठी ने कहा, 'नोटबंदी से निश्चित रूप से दिक्कतें हुई थीं, लेकिन अब लोग लंबी कतारों और नकदी के लिए इंतजार को भूल चुके हैं...हम भी कतारों में लगे थे।' उन्होंने कहा, 'लेकिन इससे निपटने का हमारा तरीका यह था। हम महिलाओं से पूछते थे कि क्या इसमें गैस सिलिंडरों के लिए कतारों में खड़े होने जितनी दिक्कत हो रही है? क्या अब आपको गैस सिलिंडरों के लिए कतारों में खड़ा होना पडता है ? इस तरह हमने नोटबंदी का

में बड़ी तादाद में होता है। यहां बच्चों के अपहरण और उन्हें मुंबई और दिल्ली के ढाबों पर काम करने या देह व्यापार में धकेलन में रेलवे का इस्तेमाल होता है। चैरिटी सेफ सोसाइटी का कहना है कि हर महीने औसतन 15 से 20 बच्चे को गोरखपुर से बचाया जाता है। दिसंबर, 2016 में यह तादाद घटकर पांच पर आ गई थी।

लेकिन नकदी ने गोरखपुर की राजनीति और उत्साह के साथ खोले गए थे। सरकार ने दावा अर्थव्यवस्था में हमेशा एक अहम भमिका किया था कि आपको सभी सब्सिडी अपने खाते िनभायी है। एक समय यह शहर भारत में हवाला में मिलेंगी। कुछ मिलना तो भूल जाइये, अब कारोबार का सबसे बडा केंद्र था। यह नेपाल सीमा से मुश्किल से 100 किलोमीटर दूर है। नेपाल से अवैध पैसा आने से शहर का सोना और सराफा बाजार बढ़ा और आतंकी गतिविधियों के लिए धन उपलब्धता में भी बढ़ोतरी हुई। जून, 2018 में उत्तर प्रदेश की विशेष एजेंसी आतंकवाद निरोधक दस्ता (एटीएस) ने एक ऐसे शख्स को गिरफ्तार किया

यह तो महज एक घटना है। रोजगार की कमी के कारण कई दशकों से सरकारी निविदाएं एवं कोटा खरीद कारोबार का अहम स्रोत रहे हैं। गोरखपुर रेलवे से जुड़ा एक अहम शहर है। यहां विश्व का सबसे लंबा रेलवे प्लेटफॉर्म है। यहां वसुली, स्थानांतरण एवं पोस्टिंग के लिए पैसा और गैंगस्टर गतिविधियां आम हैं। जब 1980 के दशक में गोरखपुर में माफिया गतिविधियां अपने चरम पर थीं, तब माफिया गतिविधियों की डोर हरिशंकर तिवारी के हाथ में थी। तिवारी विधायक भी बने और उन्होंने 7 बार चुनाव लड़ा। गोरखपुर में माफियागीरी जाति आधारित थी। तिवारी एकमात्र ऐसे व्यक्ति थे, जो गैंगवार में जिंदा बच पाए। 1980 और 1990 के बीच के दशक में यहां गैंगवार में दर्जनों जान गईं। गोरखनाथ मठ की राजनीतिक ताकत बढ़ने से गोरखपुर में माफियाओं की ताकत कम हुई है। तिवारी अपने जमाने की जानी-मानी हस्ती थे। वह भले ही कई हत्याओं के लिए जिम्मेदार हों, लेकिन अब वह अपने अतीत की परछाई मात्र हैं। उन्हें कम सुनाई देता है। वह बुढापे में भूलने की बीमारी से ग्रस्त हैं और कई बार खुद के बेटों को ही नहीं पहचान पाते हैं। उनके दोनों बेटे राजनीति में हैं। अब गोरखपुर में कानून एवं व्यवस्था दूसरों के हाथ में है।

चुनावों के चौथे चरण से ठीक पहले 27 अप्रैल को समाप्त सप्ताह में राजनीतिक दलों ने विश्व के सबसे बड़े सोशल मीडिया प्लेटफॉर्म फेसबुक पर विज्ञापन खर्च में बढ़ोतरी की। आलोच्य सप्ताह में फेसबुक पर सभी राजनीतिक दलों का कुल खर्च 20 करोड़ रुपये को पार कर गया। आंकड़ों का विश्लेषण दर्शाता है कि खर्च में पिछले सप्ताह की तुलना में 16.1 फीसदी बढ़ोतरी हुई। फेसबुक राजनीतिक प्रकृति के मुद्दों और राष्ट्रीय महत्त्व के मुद्दों पर विज्ञापन के साप्ताहिक आंकड़े मुहैया कराती है। इस तरह के आंकड़े भारत में फरवरी से उपलब्ध हैं। इस पहल का

मकसद पारदर्शिता को बढ़ावा देना है। वर्ष 2016 में अमेरिका में राष्ट्रपति चुनावों को प्रभावित करने में डिजिटल मीडिया की भूमिका की आलोचना की जाती है। यह भी कहा जा रहा है कि ब्रिटेन में इस मुद्दे पर जनमत को प्रभावित किया गया कि ब्रिटेन को यूरोपीय संघ से अलग होना चाहिए या नहीं। फरवरी से सबसे अधिक खर्च वाले पांच पेज में से चार चुनावों में सत्तारूढ़ पार्टी को समर्थन करने वाले हैं। इनमें भारतीय जनता पार्टी (भाजपा), भारत के मन की बात और माई फर्स्ट वोट फॉर मोदी शामिल हैं। अकेले भाजपा के पेजों ने ही 5.96 करोड़ रुपये खर्च किए हैं। कांग्रेस के पेज का कुल खर्च 0.74 करोड़ रुपये रहा है। समीक्षाधीन सप्ताह के दौरान फेसबुक पर सबसे अधिक लोकप्रिय कीवर्ड 'बीजेपी', 'कांग्रेस', 'मोदी', 'नरेंद्र मोदी' और 'कांग्रेस पार्टी पंजाब' हैं। 27 अप्रैल को समाप्त सप्ताह के दौरान विज्ञापनों पर कुल 2.8 करोड़ रुपये खर्च हुए। चुनाव 29 अप्रैल को हुए हैं। गूगल भी ऐसे आंकड़े जारी कर रही है। 2 मई के आंकड़े दर्शाते हैं कि इस दिग्गज सर्च इंजन पर कुल खर्च 22.39 करोड़ रुपये पर पहुंच गया है। गूगल पर सबसे ज्यादा खर्च भाजपा ने किया है।
